Dangerous articles in baggage

Pack in Carry-on Baggage

Pack in checked-in baggage

The following restricted items must be checked by a Customer Service Agent. Camp Stoves, Dry Ice

Prohibited items

Flammable Liquids, Fireworks, Flammable gases, Corrosive Chemical Products, Small lithium battery-operated vehicles, Biohazardous or infectious materials, Radioactive products, Explosives, Toxic Substance, Magnetized Materials, Weapons, Flammable solids, Sharp objects, Oxidizer, Lithium Battery (over 160Wh)
