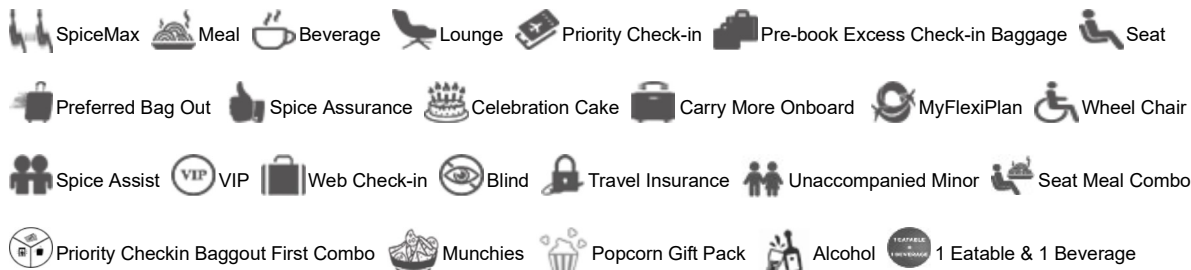

c. postpones the flight by one hundred and twenty (120) minutes or more,

the affected passengers shall be entitled either for:

i. full refund of the amount paid by them; or

ii. to be accommodated on alternate flight(s) for the same sector for next or preceding seven (07) days from the original date of journey, subject to availability and

SpiceJet's discretion in the event SpiceJet.

32. Add-on services like Meal, SpiceMax, Excess Baggage, Lounge, Priority Check-in, Preferred Bag Out are non-cancellable in isolation.
