IMPORTANT INFORMATION

- **Check-in Time** : Passenger to report 2 hours before departure. Check-in procedure and baggage drop will close 1 hour before departure.
- **DGCA passenger charter** : Please refer to passenger charter by clicking [Here](#)
- **Custom Combination** : This itinerary was created by MMT by connecting separate flights. In case of delays, schedule change, cancellation or disruption in one flight, the customer will not be eligible for refund of the non-impacted flights. Baggage allowance is decided as per the individual airline policy and may differ for each sector. You might be required to collect and check in your baggage again. You must also check the airport terminal for your next flight, as it may be different from the one you landed at. Transit Visa may be required for this booking. Please check the visa rules and policies for your transit points and final destination carefully before booking.
- **No-Show Policy** : In the event that a user does not embark on the onward journey, the entire PNR pertaining to that booking shall be automatically cancelled by the airline. In such a scenario, MMT has no control in the said process nor will be obligated to provide alternate bookings to the user. The cancellation penalty in such an event shall be as per the applicable airline rules.
- **Passengers travelling to Nepal, please note** : Who can travel? Travel is open for all visa holders. Test on Arrival: Travellers could be subject to a COVID-19 PCR test upon arrival. Documents Required: All fully vaccinated travellers must carry a vaccination certificate showing a full dose of vaccination against COVID-19, completed at least 14 days prior to entering Nepal. All partially/non-vaccinated travellers (except children below 5 years) must carry a negative test report done within the last 72 hours of boarding from the first airport. Quarantine Requirements: None. List of Accepted Vaccines: Covishield, Covaxin and Sputnik V. Please Note: - Only passport & voter ID card are allowed as valid government documents for Indian travellers. - All transit passengers (via Kathmandu) arriving in India, from China, Singapore, Hong Kong, Republic of Korea (South Korea), Thailand and Japan must: -- Carry a pre-departure RT-PCR test taken within 72 hours prior to undertaking the journey. Children below 5 years are exempted from this requirement. -- Submit complete and factual information in self-declaration form on the online Air Suvidha portal before the scheduled travel, including last 14 days' travel details. Please check all the detailed guidelines for both your chosen destination and airline by visiting our guidelines page here ?
- **Please Note** : Wearing masks/face covers is no longer mandatory. However, all travellers are advised to wear them, in view of the threat posed by COVID-19.
- **Travellers arriving in India must follow these guidelines** : Who can travel? All travellers are advised to be fully vaccinated. Test on Arrival: A sub-section (2% of the total passengers in the flight), with the exception of children below 12 years, could be subject to random post arrival testing at the airport. All travellers may undergo random thermal screening upon arrival. Please Note: All travellers arriving from international destinations and connecting to a domestic destination must recheck-in their bags at the first port of entry, regardless of through check-in done till the final destination.
- **Visa Requirements** : All travellers must present hard copies of their foreign visa (soft copies won't be accepted) at the immigration counters during departure.
